It will also facilitate a more organized and safer trip and reflect well on team members and the Academy as a professional organization. ***Any participant not willing to co-operate and comply with all terms and conditions will be strictly dealt with and as a last resort returned home at the earliest convenience at the cost of the parent. Any Adult team member not willing to co-operate and comply with all terms and conditions governing the camp will be asked to depart the touring team.*** All parents/guardians of the participating child must have read, understood, and agree with the contents of A.G.D.A. Travel Policy. These terms and conditions are compiled in accordance with the aforementioned policy.

TERMS AND CONDITIONS:

- The participating members will comprise of child participants, and AGDA Staff
- Senior coaches, Team manager and assistant team manager are the assigned ***touring team officials (T.T.O)*** responsible for all decision making for all matters affecting the safe and smooth operation of the camp.
- ***At all times*** (this includes specified training sessions, special team excursions or recreational activities, and times to be advised by the Official (Team manager/Coach), the participant will remain in the company and responsibility of one or more of the following persons: Coach/Team Manager/assistant team manager/ qualified staff member of the Active Recreation Centre, Currimundi.
- All medicinal regimes and any special dietary or medical concerns must be provided in writing (on back of Registration form) to a TTO upon arrival.
- All participants must understand that all room allocations, bed times, eating arrangements and discipline are the responsibility of the touring team officials and will be strictly monitored and exercised.
